

**SARG 2010 Summer Monsoon**  
**June 19 & 20, 2010**

**SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming. IN Sanction Number IN10296.

**LOCATION:** Huntingburg City Pool  
East 1<sup>st</sup> St. and Cherry St.  
Huntingburg, IN 47542

**FACILITY:** Six lane, 50-meter pool with non-turbulent lane lines. We will be using electronic timing with stopwatch back-up times. HY-TEK Meet Manager will be used to run the meet. Pool depth is 12 ft. at the start end and 3 ½ ft. at the turn end. **The competition course has not been certified in accordance with 104.2.2C(4).**

**COACHES:** Coaches MUST display their USA Swimming Coach Credential to gain deck access. The Meet Referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply.

**RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming Rules 202.3--At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Directors or Meet Referee shall assist the athlete in making arrangements for such supervision. Coaches and Officials must be registered with USA Swimming in order to be on the deck in the capacity and must constantly display their coach or official credentials. Access to the pool deck will be limited to coaches, swimmers, and working officials. Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of 6/19/10 shall determine the swimmer's age for the entire meet. All swimmers must compete in their own age group. If a team has a swimmer with special needs, please advise. Head Referee reserves the right to use fly-over starts if deemed necessary. Events may be combined when possible to speed up the meet. Those events will be awarded separately.

**MEET FORMAT:** All events will be Timed Finals. SARG Swim Club reserves the right to limit the number of heats in all events to keep the time line manageable. If a swimmer is cut from an event, refunds will be given for that event only. No other refund will be given. If a swimmer misses their heat in an event, the only penalty is the missed event. All teams are asked to provide 2 timers per session.

**ENTRY LIMIT:** Each swimmer is limited to 5 individual events and 2 relay events per day. If a swimmer is entered in more than the limit of events, the entry will be made by number order of events starting the event 1 until the limit is satisfied. In the event that the meet is over-entered, SARG Swim Club reserves the right to determine which entries to accept.

AWARDS: Ribbons will be awarded for 1st through 12th places in individual events and 1st through 6th place for relays. High-Point awards will be presented for each age group: 8&Under; 9&10; 11&12; 13&14; Open. Team trophies will be awarded for 1st through 3rd place.

CLERK OF COURSE: There will be a Clerk of Course for 10 & Under only.

SWIM SHOP: There will be a swim shop available for all of your swimming needs.

CONCESSIONS: A wide variety of concession items will be available. Psych sheets will be available at the concession stand for \$5.00.

HOSPITALITY: A hospitality area will be furnished for all working officials and coaches.

FINAL RESULTS: Each team shall receive a Hy-Tek file of meet results on disk or by e-mail. Individuals may purchase final results for \$5.00.

**SIGN-IN:** All swimmers are required to sign in prior to warm-ups at the sign-in table. Sign-in sheets will be taken down 45 minutes prior to the start of the session. Any swimmer who fails to sign in will be scratched from the events that day and will not be given a refund of entry fees.

**BEHAVIOR:** The SARG swim team is very grateful to the City of Huntingburg for the use of the pool and facilities. Please help to keep the pool area clean and pick up your trash. We reserve the right to expel for the remainder of the meet, with no refund of entry fees, any swimmer or person attending this meet who is caught being excessively rowdy, destructive, using foul language, or in any unauthorized areas. Coaches and parents are expected to keep their swimmers under control at all times. It is recommended that swimmers leave all valuables with an adult.
